**OFFICIAL RULES** 

- 1. HOW TO ENTER: NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. In order to enter, log on to the 1065thearch.cfom website ("Website") and click on the "Spencer's Neighborhood's Fantasy Football Throwdown Contest" icon. This contest will run from 12:00:00 AM Central Time ("CT") on August 7, 2017 through 11:59:59 p.m. CT on December 31st, 2017. ("Contest Period"). The Contest Period consists of two periods: (1) the registration/win your spot on the league period, which starts at 12:00:01 a.m. CT on August 7, 2017 and ends at 11:59:59 p.m. CT on August 23rd, 2017 ("Registration Period"); and (2) the fantasy football period, which begins at 6:00 p.m. CT on August 31st, 2017 and ends at 11:59:59 p.m. CT on December 31st, 2017 ("Fantasy Football Period"). WARH-FM is not responsible for problems accessing the website, technical or atmospheric conditions that disrupt the completion of the registration or Contest play, or any other problems which might or might not result from this Contest.
- 2. HOW TO ENTER/PLAY: NO PURCHASE NECESSARY.

This sweepstakes requires participants to be members of the Arch Allies Rewards Club in order to participate. Entries will be accepted from Monday, August 7th, 2017, through 11:59:59 p.m. on Wednesday, August 23rd, 2017.

- a. <u>ARCH ALLIES Rewards Club Membership Required.</u> To participate in the sweepstakes, listeners must be members of the Arch Allies Rewards Club. To become a member of the Arch Allies Rewards Club, log on to www. 1065thearch.com and complete the form to become a member. Please note, Arch Allies program will no longer exist after December 31st, 2017.
- b. How to Enter/Win. 2. HOW THE WINNER IS CHOSEN: From all eligible entries received pursuant to Paragraph 1 above, ten (10) names will be randomly drawn at The Arch Studios by Friday, August 25<sup>th</sup>, 2017. The winner will be notified by telephone and/or email and must be in attendance at the draft party on August 31<sup>st</sup>, 2017 at the Buffalo Wild Wings in Creve Coeur, Missouri.

3. PRIZES: There will be ten (10) winners in this sweepstakes. The winner(s) will receive a spot on Spencer's Neighborhood's Fantasy Football League for a chance to win a Yeti Cooler. Value of the prize is \$0. Each winner is responsible for his/her own transportation to and from the venue, as well as all other expenses (i.e., food, beverages, programs, parking, etc.).

A qualified winner must also meet the eligibility requirements as set forth in Paragraph 5 of these rules. The winner is responsible for paying all applicable income taxes. ## 3. HOW TO PLAY/HOW THE WINNER IS CHOSEN.

a. Draft Day/Roster Selection: Once you have been notified as winning your spot on the league, you must register your League on the Yahoo! Fantasy Football website. Directions and link information will be sent out to all winners no later than August 25<sup>th</sup>, 2017. Each Team member will have to attend the Draft Party which will occur on August 31st, 2017 at 7:00 PM CT at Creve Coeur Buffalo Wild Wings. Prior to the draft – league participants will be sent a unique Draft Link provided in a "draft calendar" email that will be sent out to all League owner registrants at 6:00 pm Central Time on August 31st, 2017, to draft players for your Team roster. During the draft, each Team owner will select from among all available players listed on the Fantasy Site, 15 players for his/her Team (how many players for each position on your Team is up to each Team owner). The order for the draft will be randomly computer generated by the Fantasy Site. Once a Team's roster has been completed, players may NOT be traded out.

b. How to Earn Points/Win: Each week throughout the Fantasy Football Period, a Team will select their fantasy football starting lineup from among all drafted players on their Team. Team players in the starting lineup at the start of their specific game time will accrue points based on the Yahoo scoring settings that are set for the entire League. A Team's fantasy football total is accumulated over the course of 17 NFL fantasy football weeks as defined on the Fantasy Site and the Team with the most fantasy football points from among Spencer's Neighborhood's Fantasy Football Throwdown League at the conclusion of the Fantasy Football Period will be the grand prize winner.

Teams score points based on their individual player performances on his/her Team each week throughout the Fantasy Football Period across several different statistical categories as set forth on the Fantasy Site. Teams can watch scores update in real-time using the Fantasy Site's live Stat Tracker, Fantasy Sports mobile app, your Team weekly matchup page, or even while just checking your Team roster. Teams' stats equal points based on values chosen by the League's commissioner at the outset of this Contest. Compete with the other Teams in your League to finish with the most points over the entire season. Players traded or dropped from your Team will score points or compile stats for your Team until the trade or drop is finalized and Teams keep all points or stats earned up to that point. Teams don't inherit points or stats from a player that were earned on another Team, or while that player was on Waivers or in Free Agency.

- c. Tie-Breaker: In the event of a tie, the Team who scored the highest as of the week preceding the last week of the Fantasy Football Period will be deemed the winner from among all tying Teams. In the event a tie still exists, the Team who scored the highest the third to the last week of the Fantasy Football Period will be deemed the winner from among all tying Teams. In the event a tie still exists, this tie-breaking method going backwards in time will continue until there is a week where one Team had a higher score than the other tying Team or Teams.
- 3. PRIZES AND APPROXIMATE RETAIL VALUE ("ARV"): ONE (1) GRAND PRIZE: There will be one (1) grand prize winner in this Contest as set determined in Section 2 b. above. The winner will receive a customized Yeti 35-Tundra Cooler. Total value of the grand prize is \$300.00.
